



CIPS ANNUAL REPORT 2021-2022









As Canada emerges from the pandemic, CIPS is also re-emerging on the provincial, national, and international stages as we communicate and collaborate with IT professionals and partners from across the ICT landscape in Canada and beyond.

The cornerstone of CIPS is our commitment to the ethical practice of IT. CIPS is a founding member of the International Federation for Information Processing (IFIP), who have recently released a new Code of Ethics. The Board of Directors has adopted this new IFIP Code of Ethics as our foundation for ethical practice going forward and our focus over the next while will be to have this code adopted by the provincial societies and incorporated into the ethics requirements for their members.

We held our annual cross-country strategic planning session in November 2021, once again virtually. As our strategic planning efforts over the years bear fruit, two themes have begun to emerge that are driving our thinking and action. The first is community - CIPS as Canada's Association of IT Professionals has traditionally been first and foremost a place for IT professionals to gather, whether they work in industry, academia, or government. It is clear that there is both a need and a hunger for a gathering of our IT community at all levels and it our hope that once again CIPS can bring our communities together for mutual benefit. The second is skills - our country faces both a skills shortage in ICT and also a skills mismatch - the skills that Canada needs to grow in the 21st century are changing rapidly. Our members and our stakeholders feel this pain every day. We must be part of the solution to this skills emergency and help Canada have a robust digital skills supply. It is our belief that we can do this by helping Canadians in ICT speak a common language - the Skills Framework for the Information Age (SFIA). We have been a long-time supporter of the SFIA Foundation and a driver of its adoption internationally through the International Professional Practice Partnership (IP3). This work is key to realizing our mandate as the ethical and skilled IT professionals in Canada.

As we continue our mission to obtain the right to title for IT practice in every province and territory (and one day right to practice legislation in Canada), provincial societies must evolve into their future as professional regulators. This will require robust professional practice, registration, and discipline committees in every province. CIPS is committed to supporting the provincial societies in this endeavour. Volunteerism is on the decline right now, not just in CIPS but broadly across society. The CIPS National office will be working with provincial societies to help with administrative work like bookkeeping, routine correspondence, and other tasks to free up volunteer time for the important work provincial societies need to be doing in their communities liasoning with their members and stakeholders.

Our CEO, Greg Lane, FCIPS, I.S.P. (ret.), continues to shine as he leads our organization into the future. His work in building bridges within our ICT community in Canada as well as with our

international partners has been inspirational to witness. Terms of reference have been adopted for an advisory board to support this and other work directly. Greg has been instrumental in supporting provincial societies as they work with their respective governments on opportunities for grant funding for support to build Canada's digital skills supply, particularly in Ontario, Saskatchewan, and Alberta. Our Operations team led by our COO Mary Jean (MJ) Kucerak, CAE has been ably supporting Greg in his work and our provincial societies and we were pleased to renew her contract. I would be remiss if I did not also highlight the great work that our Chief Marketing Officer, Jonathan Elias, has done both day-to-day and in building a strategic marketing annual plan that we have been sharing widely with our partners.

I am standing again for election as Chair of the Board for 2022-2023, which is the last term I am eligible to serve. Succession planning will be top of mind for myself and the Board. Our important work must continue and to that end I ask for our Board to continue to support our CEO in his endeavours. Work remains to refine our strategy and match it with sustained execution. As we approach the 65th anniversary of CIPS, we have a proud legacy but must protect it and the public interest for many years to come.

On behalf of CIPS, I would like to thank the many volunteers and staff who support our mission, particularly my fellow Board members, our National office staff, and our provincial society leadership and their office staff. Our work would not be possible without you and your dedication to IT professionalism in Canada.




CEO Report

July 2021 - June 2022

This twelve-month period we continued to build in our 3 focus areas: Brand and Awareness, Professional Development, and National Office Operations. Building "community" has become a key aspect of Brand and Awareness. We continue to reach out to likeminded organizations to share perspectives and to look for opportunities to collaborate. The creation of our CIPS diagram "Canada's Digital Skills Supply" makes it clear what CIPS is trying to do and how stakeholders

can contribute and collaborate.



We are working to improve the Supply of Competent, Ethical IT talent in Canada by supporting systemic change. Canada needs to enhance and improve all aspects of talent development including traditional education paths. We have presented and discussed this diagram with key stakeholders including the Federal Government, key partners, provincial governments, and academic partners. As well we are working on initiatives in all areas identified in the diagram. As a key enabler to allow these different channels to produce appropriate talent, we are advocating that a common language be used to assess areas and level of talent- SFIA. The Skills Framework for the Information Age (SFIA) allows all stakeholders to understand and measure talent. This year CIPS has had several opportunities to speak at events and conferences and the diagram and our desire to grow Canada's IT Talent pool for Canadian competitive advantage are central to our message.

Specifically, we continue to collaborate with CIO-CAN and are sharing our marketing calendar to enable more "joint" events. We have signed MOUs with BTM and CS Can two significant academic bodies that produce the next generation of IT leaders and contributors. We want to improve the connection of Industry and Academia by having more CIPS guest speakers in classrooms and by holding events with a student focus. We are working with several organizations to support new Canadians getting into IT careers better and faster. We are supporting the Federal Government with a program to attract and train more indigenous people to careers in IT. All the proposals or presentations are maintained by National as assets that can be used by any and hopefully all Provincial Societies to advance the conversation locally.

Looking forward we hope the benefits of CIPS membership make attracting members more fun. As we move into our 65th year we need more volunteers to maintain momentum and to continue to have our voice heard.

Director of Finance Report



This report contains an update on the 2020-2021 audited financial statements, the 2021-2022 unaudited financial results and a look ahead to our financial plan for 2022-2023.

2020-2021 Audited Financial Statements

The 2020-2021 audited financial statements, which we will be asking membership to approve, show that the year ending June 2021 resulted in a revenue deficit of (\$4,248). Fiscal 2020-2021 saw a year over year reduction in Net Assets of less than 1%, an increase in revenue of 10%

and an increase in expenditures of 20.6%. The year over year increase in expenditures is primarily due to increased administrative costs, intended to bring focus to our CIPS National growth initiatives.

2021-2022 Financial Results

Thanks to a very active CIPS National office, there have been great efforts to increase the visibility of CIPS and the value that we deliver to our members and industry.

The pandemic continues to have a negative impact on membership numbers. Much of our membership growth over the past few years was attributed to international membership. The pandemic-induced Canadian immigration backlog has caused a noted decline in this segment of our membership. There is optimism, however, as the Canadian Immigration wheels are once again beginning to turn.

Unaudited financial results show that we finished the year off stronger than budgeted.


2022-2023

Programs accredited by the BTM are those leading to business technology degree at the bachelor's level.

Our accord is non-governmental and is not affiliated with any country. CIPS is a founding signatory to the Seoul Accord and CSAC's accreditation processes were accredited by the SEOUL Accord in 2018.
